BYLAW NO. 2018-03**

A BYLAW FOR THE RURAL MUNICIPALITIES OF ARLINGTON NO. 79, WHITE VALLEY NO. 49, GRASSY CREEK NO. 78, BONE CREEK NO. 108, RENO NO. 51, THE TOWNS OF EASTEND AND SHAUNAVON, AND THE VILLAGE OF CONSUL, IN THE PROVINCE OF SASKATCHEWAN, FOR THE PURPOSE OF ENTERING INTO AN AGREEMENT FOR THE CREATION OF A DISTRICT BOARD OF REVISION.

The Council of the Rural Municipality of Bone Creek No. 108 in the Province of Saskatchewan under the authority of Section 222 of *The Municipalities Act* enacts as follows:

- 1. The Council for the Rural Municipality of Bone Creek No. 108 is hereby authorized to enter into an agreement with the Council for:**

for the purpose of establishing a District Board of Revision, the terms of which are attached hereto and marked "Exhibit A".

- 2. The Reeve and Administrator of the Municipality are hereby authorized to sign and execute an agreement, the terms of which are set in "Exhibit A" herein before referred to.**
- 3. Bylaw 2014-07 is hereby repealed.**
- 4. This Bylaw becomes effective on the date that all participating municipalities have signed the Memorandum of Agreement.**

THE MEMORANDUM OF AGREEMENT
For the Establishment of a District Board of Revision

1. **DATE OF AGREEMENT:**

This Memorandum of Agreement is made this 9th day of May, 2018 A.D.

2. **PARTIES TO THE AGREEMENT:**

This Agreement is made by the following parties:

The Rural Municipality of White Valley No. 49
in the Province of Saskatchewan

The Rural Municipality of Wise Creek No. 77
in the Province of Saskatchewan

-and-

The Rural Municipality of Grassy Creek No. 78
in the Province of Saskatchewan

The Rural Municipality of Arlington No. 79
in the Province of Saskatchewan

The Rural Municipality of Bone Creek No. 108
in the Province of Saskatchewan

The Rural Municipality of Reno No. 51
in the Province of Saskatchewan

(Hereinafter referred to in aggregate as the “Municipalities”)

3. **PREAMBLE:**

Whereas the municipalities hereto voluntarily and collectively intend to establish a DISTRICT BOARD OF REVISION (hereinafter referred to as “the Board”), to hear and decide appeals received, pursuant to Section 222 of *The Municipalities Act*, from within the municipalities to this agreement. And that this District Board of Revision shall be titled: “THE PINE CREE DISTRICT BOARD OF REVISION”.

4. **AUTHORITY:**

The District Board of Revision is being established under the provision of Section 222 of *The Municipalities Act*.

5. **TERMS OF THE AGREEMENT:**

- (1) That Gord Krismer and Associates Ltd. are appointed to act as the Board of Revision.
- (2) The Secretary of the Board, in consultation with the Administrator’s of the municipalities, shall coordinate the activities of the Board and coordinate information between the municipalities.
- (3) The municipalities shall pass complimentary resolutions appointing Gord Krismer and Associates Ltd. as the Board and the amount of remuneration to be paid for their services.

- (4) The municipalities shall pass complimentary resolutions approving the appointment of a secretary to the Board and the amount of remuneration to be paid for his/her services.**
- (5) In the event of any dispute between the municipalities regarding appointments or remuneration, the matter shall be determined by a majority of the participating municipalities.**
- (6) The Rural Municipality of Bone Creek No. 108 shall pay for all expenses related to the operation of the Board, recovering the costs from the participating municipalities in an equal amount.**
- (7) No municipality shall pay less than \$250.00 annually as its share of the cost for the operation of the Board. The \$250.00 fee is due and payable by March 1st of each year. This recognizes the costs charged by the Professional Board of Revision service and for the secretary. Should total expenses of the Board exceed \$1,750.00 in any one year, the excessive amount will be recovered from the participating municipalities.**
- (8) Any municipality may withdraw from this agreement by providing written notice prior to January 15th of any year. Such notice of withdrawal shall be delivered to the Administrator’s of the municipalities of this agreement.**
- (9) Additional municipalities wishing to become a party to this agreement shall be required:
a) to obtain the written approval of the originating municipalities; and
b) to provide in the first year of participation a fee equivalent to the total current amount in the fund divided by the current number of participants.**
- (10) The annual fee referred to in item 7, may be waived by the participating municipalities if they believe there is a sufficient amount of funds available.**
