A Bylaw of the Rural Municipality of Bone Creek No. 108 to designate a site Municipal Heritage Property

WHEREAS Sections 11 and 12 of the Heritage Property Act authorize the Counc: of a Municipality to enact bylaws to designate real property, including al buildings, features and structures thereon, to be of heritage value; and,

and located at: all that portion of the South West Quarter of Section Fiftee (15) in Township Eleven (11), in Range Eighteen (18) west of the Third (3 in the Province of Saskatchewan, in the Dominion of Canada COMMENCING at a point on the Southern boundary distant Two Hundred Feet (200 from the Southwest corner thereof; thence Northerly parallel with the Wester boundary, three Hundred (300) feet; thence Easterly parallel with the sai Southern boundary Three Hundred (3)) feet; thence Southerly parallel with th said Western boundary to the said Southern boundary, thence Westerly along th said Southern boundary to the point of commencement, Excepting thereout Parcel "b" containing Ten Hundredths (0.10) of an acre, more or less, taken fo Roadway as shown upon a Plan of Record in the Land Titles Office for the Swif Current Land Registration District as No. 64-SC-08312,

is a site of architectural, historical, clutural, environmental, archaeological palaeontological, aeshetic and/or scientific value; and,

WHEREAS the Council of the municipality has caused, not less than thirty (30 days prior to consideration of this bylaw, a Notice of Intention to designat to be:

- served on the owners of said property;
- served on the Registrar of Heritage Property
- registered on the Certificate of Title for said property in the appropriat. Land Titles Office; and
- d) published in at least one issue of a newspaper with general circulation in the municipality; and,

WHEREAS no Notice of Objection to the proposed designation has been served or the Council of the Municipality;

THEREFORE, the council of the Rural Municipality of Bone Creek enact as

there is designated as Municipal Heritage Property the real property legally described as all that portion of the South West Quarter of Section Fifteen (15) in Township Eleven (11), in Range Eighteen (18) west of the Third (3) Meridian, in the Province of Saskatchewan, in the Dominion of Canada, COMMENCING at a point on the Southern boundary distant Two Hundred Feet (200) from the Southwest corner thereof; thence Northerly parallel with the Western boundary, three Hundred (300) feet; thence Easterly parallel with the said Southern boundary Three Hundred (3)) feet; thence Southerly parallel with the said Western boundary to the said Southern boundary, thence Westerly along the said Southern boundary to the point of commencement, Excepting therwould: Parcel "b" taining Ten Hundredths (0.10) of an acre, more or less, taken for Roadway as shown upon a Plan of Record in the Land Titles Office for the Swift Current

Land Registration District as No. 64-SC-08312,
